I humbly submit that as per above subject and reference, in the connection of Show Cause Notice (SCN) Page 18-20, issued in the 319<sup>th</sup> Meeting of the WRC held from 20<sup>th</sup> and 21<sup>st</sup> October, 2020, We applied earlier to NCTE for approval as **Shyam College (NRCAPP201615548)** for B.Ed. course, Khasra No. 225, Village Dehlal, Post Office Didwana, Tehsil Ramgarh Pachwara, District Dausa, Rajasthan-303511. **Now it has been vested as per clause 3 (2) and Schedule-I & II in The Shyam University, Dausa Act, 2018**, established by the Govt. of Rajasthan wide Act No. 28 of 2018 which has received assent of Hon'ble Governor of Rajasthan and same being notified in the Rajasthan Gazettee Notification vide No. F.2 (16) Vidhi/2/2018 Dated 05 Oct., 2018 (Page 9-80).

We had applied earlier to NCTE as **Shyam College** along with the NOC of The University of Rajasthan (Page 81) and after the application submitted to NCTE, **it has been vested as per clause 3 (2) and Schedule-I & II in The Shyam University, Dausa Act, 2018** and in the compliance of the order issued by the Govt. of Rajasthan wide letter No. P.3 (1) Edu.-4/2016, Jaipur, Dated : 15/03/2017 (Page 82), we intimated to the University of Rajasthan for change of the affiliating body on Dated 14/02/2019 by Speed post (Page 83). We contacted personally in the office of Registrar to issue NOC for change of the affiliating body, but they told that you should not require the University of Rajasthan NOC because University of Rajasthan has not issued affiliation to your college till date. The NOC of present affiliating body Shyam University is enclosed (Page 84). As requested above, this institute after change in the name of the institute will be known as **“Department of Education, Shyam University”** and the affiliating body will be the Shyam University. You are requested accordingly to make necessary changes in the WRC-NCTE record.
